#### NEW EXHIBIT

"The Formation of Proctor and West Rutland (1886)" is the Spring exhibit of the Rutland Historical Society. The exhibit explores the historical background of sectionalism in the old Town of Rutland. It also deals with the issues that brought the old Town of Rutland to division into multiple towns in 1886. The exhibit includes maps and pictures of many of the people who played roles in the formation of the Town of Proctor and the Town of West Rutland from the old Town of Rutland.

#### ANONYMOUS GIFT TO G.A.R. WINDOW FUND

The Rutland Historical Society was of recipient recent anonymous donation of \$425 to assist in the restoration of two stained glass windows from the old G.A.R. Memorial Hall. This gift brings the total funds raised for this purpose to \$578 which is about two-thirds of the monies needed to restore both windows. With this in view, the Board of Directors has sent both windows for restoration work. It is to be hoped that the remaining \$302 required may be raised through further entries in the Civil War Memorial Book (see News from Nickwackett Vol. 2 No. 4 December 1995 page 3 for details) and general contributions to the restoration fund (see News from Nickwackett Vol. 2 No. 3 page 2).

#### **MEMBERSHIP DRIVE**

**Why?** Making a sizeable increase in the membership of the Society is crucial to stabilizing our publication costs which are a large part of our annual budget. We wish to hold the line on our membership costs without reducing either the quantity or quality of our publications. In fact we would like to increase both. How can we do this without increased cost to the individual member? The key lies in the fact that as we increase our membership we can decrease the per member cost of the publications we provide. For example, if we had 5,000 members rather than 500 members our per member cost would be about half the current cost. Thus increased membership is a way that each member can help the Society and at the same time help to hold down the cost of individual membership.

#### RUTLAND WRAPPER AND SKIRT COMPANY

A recent article in the Rutland Herald regarding the dismantling of the Olney Apartments on West Street in Rutland prompted a letter to the Society from Elaine M. Peterson. The following is excerpted from her letter

"My mom started working there [in the factory] at age 14 when it [the Rutland Wrapper and Skirt Companyl opened in 1903. She learned to make collars and finally went to attaching them to shirtwaists. [She] worked from 6:00 a.m. to 6:00 p.m. at \$4.00 a week."

"[She] would take [the] trolley from West Rutland early as she had to walk [up] the hill to be at work at 6:00 a.m. In later years it went to piece work. Then at times she made more. The trolley was 5 to 10 cents per day to ride. She worked there until she was hired in West Rutland."
