

BUILDING FUND UPDATE

In our Summer 1989 Newsletter a headline stated that members had given \$16,776 to the Nickwackett Building Fund. Actually, while the total was correct \$6,000 of that was improperly credited which we do sincerely regret.

We received a \$4,000 Grant from the Fund for Vermont's Third Century which must be matched. Another \$2,000 came from the Windham Foundation of Grafton. So the total from members at that time was \$10,776. As of now member contributions total \$13,691. The total received in matching funds is \$760, leaving \$3,240 to be raised by midsummer.

Much more is needed to complete this building project. If you haven't given yet we hope you will consider doing so soon. All contributors will be listed on a plaque in the building eventually.



Repointing the brick has been completed and the results are terrific. With plastic covering the scaffolding and a propane heater going full blast John Timms and his helpers were able to work even in December's bitter cold. The thermometer went over 32 degrees only once in the whole month! A temperature of 40 is necessary for proper setting of the mortar.

We do not have a firm date for the rehabilitation to be completed, mayhap in late summer. It has been a trying time for historical research with the Rutland Free Library's Vermont Room collection in storage, the Vermont Historical Society closed for a while for asbestos removal and our own collection almost inaccessible and in storage for 11 months.

Two albums of photos of the Farm Museum collection with documentation was compiled by Ernie Hathaway. The pictures were taken by Joanna Seward with assistance from Bonnie Horn. Jim Davidson, Arch Todd and Moe Tucker helped with the documentation. One album will remain with the historical society and an identical one was given to the Rutland County Agricultural Society.

The "Our Town" series last fall was very well received. The informal round table format gives everyone a chance to contribute with worthwhile information and stories about Rutland's past. The series will not be held this spring. Instead the program committee is working to prepare a series for presentation on Public Access Channel 15 in the fall. Sounds like a great idea

RUTLAND GENEALOGY BOOK

Collecting pictures for the forthcoming book of genealogies of early Rutland families has been a most enjoyable experience. Many people have invited me into their homes, shared family anecdotes and relics and allowed their photos to be copied.

Eleanor Elwert, Warren Dexter, our photographer, and myself spent a day (we needed a week!) at the home of Dorcas Chaffee in Lyme N.H. Her house was filled with treasures - oil paintings of the Gove family, pictures of the Thralls and Chaffees besides a great many early letters and papers. Mrs. Chaffee has graciously offered to let the society duplicate any of these.

I also appreciate the kindness of Araby Gilmore who allowed me to make selections from her valuable collection on West Rutland. Gladys Kenney of Springfield, Massachusetts, who inherited many of the Mead and Gorham photos from the Florence Mead estate, has been very generous.

It is always exciting to uncover oil paintings as many pre-date photography. The latest finds are of Dr. Joel Green (1831), Daniel Sullivan Ewing, his wife Polly (Tuttle) Ewing and her mother, Martha (Thomas) Tuttle who died in 1848. The Green portrait is at the Springfield Art and Historical Society. The Ewing pictures are owned by Elizabeth (Ewing) Fox of Westport, N.Y.

Finding the Ewing portraits is an example of the fun and rewards of genealogical research. When I did my book on the history of the town of Shrewsbury I came across the Polly Tuttle will which listed the three portraits and to whom they would go. A phone call and voila! we will receive photo copies for the book.

The book. It will contain two hundred genealogies and over one hundred photos and will be available by fall. Watch for pre-publication announcements.

Murray was a resident of Rutland, Massachusetts and the first named proprietor in the Rutland, Vermont charter given by Gov. Benning Wentworth of New Hampshire.

HISTORICAL SURPRISES

Historical surprises happen all the time. The one we will tell you about was lots of fun. In early June 1980 the society had not managed to plan an exhibit for the summer when the museum would be open. What to do?

Enter Meg Ostrum, at the time a consultant in the museum field for the state. She came down, asked what did we have and, after hearing the list, made some valuable suggestions.

The eventual result was "Rutland Experiences the West" an exhibit which won the Award of Merit in the exhibit category from the Vermont Historical Society. Included was material from our Ella Bean Livingston Indian Collection, William Henry Jackson photos of the west, "Bronco Charlie" Miller, the last Pony Express rider, Wild West Show advertisements and many photos of Indians which were loaned to us.

The day before the exhibit opened we received in the mail a letter from a lady in Arizona which she had sent to the Rutland Postmaster. Here's what she said:

Dear Sir:

A few days ago we were celebrating the "glorious fourth" here in this little Arizona town down on the Mexican border with marching bands and floats and fireworks in the evening. I'm sure the day was being marked in a similar fashion in Rutland, Vermont.

By a strange coincidence I was going thru an old trunk a day or so later and came across this letter written by a Mr A B Foote to my grandfather who had just left Rutland to try his luck in Wisconsin. My grandfather's name was John Perkins Woodward and my grandmother was a Mary Dodge. I believe they resided in Benson, Vermont just before moving to Wisconsin.

Is there still a Rutland Herald after all these years? If so the Editor might like this account of the celebration of July 4th 1855. Some of the names mentioned may still be extant in that area.

I am one of the few living descendants of John Perkins Woodward and feel this letter should go back to Rutland. If you have an Historical Society I'm sure they would like it eventually....

I shall deeply appreciate your seeing that this letter gets into proper hands.

Needless to say it did, in fact it was reprinted in the Fall 1980 Quarterly, Vol. X No. 4. We had it photocopied and highlighted it in the part of the exhibit that showed advertisements for Wild West Shows.

Since it is four long handwritten pages we will excerpt only a small amount.

"...The celebration of "The Glorious Fourth" in this place, showed that Rutland isn't dead yet. "The Day" was ushered into Rutland at half past six (or thereabout) in the morning; at which time a bunch of firecrackers -ignited- were thrown into Thrall's office window by "Reuben's" hired man. At 10 o'clock a very large quantity of fire-crackers were lighted and thrown into "an empty barrel of flour" placed on the common for that purpose. The effect was truly startling!....

So then you get the Rutland Herald, do you? Look out then for a little "more of the same sort" of doggerel. I commenced some this morn-could not make it go to suit-dropped it and "took up my pen to inform you" -&- have now I see got to the bottom 4th page of my sheet [this letter]-after which, if sufficient light breaks in upon me, shall try to finish said doggerel today-and if I do, may be 'twill appear this week-Excuse the wretched penmanship and give my respects to Mr. T and all "enquiring friends". Write again when convenient and be assured, for the present of my "high esteem, etc."

Herewith a sample of Foote's poetry taken from a volume edited by Abby Maria Hemenway titled "Poets and Poetry of Vermont". It was published in Rutland by George A. Tuttle in 1858.

THINKS I TO MYSELF

I saw her again but a few days ago,
When Kossuth came down to our city;
The name of the lady I never did know,
But thinks I, she's uncommonly pretty;
And witty,
And clever, no doubt, as she's pretty.

NECROLOGY

Kenneth Fisher - died April 28, 1984. Graduate of Brown University. Worked for General Motors for many years. He was an avid fisherman and hunter and a charter member of the society.

Rita L. Bole - died October 6, 1989. Miss Bole taught in rural schools and at Lyndon Institute. From 1927 to 1955 she was head of Lyndon Normal School. She was the first President of Lyndon State College, named to the position in 1947. She was 94 years old.

Thomas Kiernan Egan - October 12, 1989. 75 years. The consummate Irishman, multi-talented. The creative juices were always flowing, very often on behalf of the Historical Society resulting in awards from the Vermont Historical Society and the Association for State and Local History. There aren't many people like Tom around. We were blest that he included the society in his endeavors.

Edward McClallen, Jr. - October 28, 1989 at 81 years. Served as a Rutland alderman, judge in the Municipal Court and from 1967-1979 he was the judge in the District Court.

W. Joseph Simonds - died September 19,1989 at 73 years. Rutland City Treasurer for 32 years, an exemplary city employee.
